CONTRACT AGREEMENT

THIS AGREEMENT made this <u>12th</u> day of **December**, 2022 between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and FATIMA E.
