### **CONTRACT AGREEMENT**

THIS AGREEMENT made this 12th day of December , 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and EDEN D. AUDAL Proprietor of OPFERN HARDWARE & CONSTRUCTION SUPPLIES (hereinafter called the "Supplier") of the other part:
