#### CONTRACT AGREEMENT

THIS AGREEMENT made this 16th day of December, 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and PAUL DESCALLAR DINO Proprietor RMM CATERING SERVICES (hereinafter called the "Supplier") of the other part:


