CONTRACT AGREEMENT

THIS AGREEMENT made this 2nd day of March , 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and MA. ELENA T. MORADA proprietor of 38MJ ENTERPRISES (hereinafter called the "Supplier") of the other part:
