### CONTRACT AGREEMENT

THIS AGREEMENT made this **3rd** day of **March , 2023** between **Ma. Ester E. Hamor , City Mayor, City of Sorsogon** Philippines ( hereinafter called the “ Entity” ) of the one part and **JOSEPH MARK M. PARAS** publisher of **SORSOGON TODAY** ( hereinafter called the “Supplier” ) of the other part:

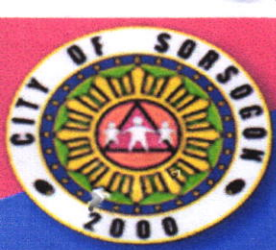

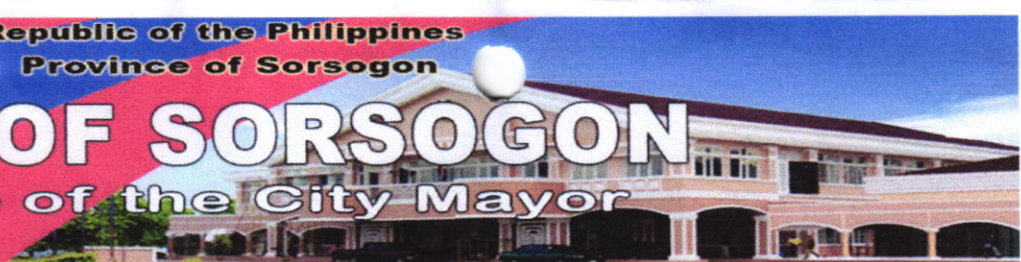
