CONTRACT AGREEMENT

THIS AGREEMENT made this 3rd day of **March**, 2023 between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the “ Entity ”) of the one part and **FATIMA E. LEE** proprietor of **F.E. LEE ENTERPRISES** (hereinafter called the “ Supplier ”) of the other part:

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder’s conforme thereto; and


