



### CONTRACT AGREEMENT

THIS AGREEMENT, made this 6<sup>th</sup> day of December, 2022 between CITY GOVERNMENT OF SORSOGON, City Hall, Cabid-an East Dist. Sorsogon City (hereinafter called the "Entity") and **iCONST ARCHITECTURAL DESIGN CONSTRUCTION & DEVELOPMENT** with office address at Blk 2 Lot 6 Tanchuling Subd., Rawis, Legazpi City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **CONSTRUCTION OF SLOPE PROTECTION , Housing Project , Bibincahan, East District Sorsogon City** under Contract Reference No. CW 2022-10-056 (hereinafter called "the Works") and the Entity has accepted the Bid of One Million Nine Hundred Thirty Six Thousand Eight Hundred Forty Four & 66/100 Pesos (Php 1,936,844.66 ) Only by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

    - v. Supplemental or Bid Bulletins, if any;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - c. Performance Security;
  - d. Notice of Award of Contract and the Bidder's conforme thereto; and
  - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **One Million Nine Hundred Thirty Six Thousand Eight Hundred Forty Four & 66/100 Pesos (Php 1,936,844.66 ) Only** or such other sums as may be ascertained, **iCONST ARCHITECTURAL DESIGN CONSTRUCTION & DEVELOPMENT** agrees to **CONSTRUCTION OF SLOPE PROTECTION , Housing Project , Bibincahan, East District Sorsogon City** in accordance with his/her/its Bid.
