

#### CONTRACT AGREEMENT

THIS AGREEMENT, made this 27th day of December, 2022 between CITY OVERNMENT OF SORSOGON, City Hall, Cabid-an East Dist. Sorsogon City (hereinafter SIATING CONSTRUCTION & DEVELOPMENT with office address lled the "Entity") and anacud, Magallanes, Sorsogon (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute CONSTRUCTION OF MULTI-PURPOSE BUILDING BONGA, BACON DIST. under Contract Reference No. CW 2022-10-072 (hereinafter called "the Works") and the Entity has accepted the Bid for One Million Eight Hundred Eighty Five Thousand Ninety Six & 82/100 Pesos (P ₱1,885,096.82 ) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are 1. respectively assigned to them in the Conditions of Contract hereinafter referred to.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
