## **CONTRACT AGREEMENT**

THIS AGREEMENT made this <u>16th</u> day of **December**, 2022 between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and JOHN ANTHONY E. ESTIPONA proprietor of UNA PIZZERIA (hereinafter called the "Supplier") of the other part:

iii. Performance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and


