## CONTRACT AGREEMENT

THIS AGREEMENT made this 3<sup>rd</sup> day of April ,2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and AGNES TAN Authorized Representative of JEANEE'S SUPERMART & DEPARTMENT STORE, INC. (hereinafter called the "Supplier") of the other part:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

iii. Performance Security;

ECEV. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of Seven Hundred Ninety Two Thousand Six Hundred Sixteen & 50/100 Pesos (₱ 792,616.50) Only or such other sums as may be ascertained, JEANEE'S SUPERMART & DEPARTMENT STORE, INC. agrees to viz SUPPLY AND DELIVERY OF MASSAGE KITS FOR USE IN THE OSY TRAINING in accordance with his/her/its Bid.


