

CONTRACT AGREEMENT

THIS AGREEMENT made this **31st** day of **March**, **2023** between **Ma. Ester E. Hamor**, **City Mayor**, **City of Sorsogon** Philippines (hereinafter called the "Entity") of the one part and **RHEA J. OLAYRES** proprietor of **BRYSAM ENTERPRISES** (hereinafter called the "Supplier") of the other part:
