

### CONTRACT AGREEMENT

THIS AGREEMENT made this **3rd** day of **February**, **2023** between **Ma. Ester E. Hamor**, **City Mayor**, **City of Sorsogon** Philippines (hereinafter called the "Entity") of the one part and **JENNY VIF. CANLAS** Proprietor of **J.
