THIS AGREEMENT made this **2nd** day of **March, 2023** between **Ma. Ester E. Hamor, City Mayor, City of Sorsogon** Philippines ( hereinafter called the " Entity" ) of the one part and **JENNY VI F. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **Two Hundred Twenty One Thousand Four Hundred Forty Pesos ( P 221,440.00) Only** or such other sums as may be ascertained, **J. CANLAS AUTO PARTS** agrees to viz **SUPPLY AND DELIVERY ADDITIONAL SPAREPARTS & OIL FOR MARCH 2023** in accordance with his/her/its Bid.





4. The City Government of Sorsogon agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




