CONTRACT AGREEMENT

THIS AGREEMENT made this 21st day of April, 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and ARIEL D. ARSSI CONSTRUCTION AND SUPPLY (hereinafter called the . Proprietor of DESPUIG "Supplier") of the other part:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Performance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and
