CONTRACT AGREEMENT

THIS AGREEMENT made this 28th day of April , 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and JUDITH A. TUMALAD proprietor of JAD MARKETING (hereinafter called the "Supplier") of the other part:
