### CONTRACT AGREEMENT

THIS AGREEMENT made this 5th day of May, 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and MILAGROS D. LIAO Proprietor BIG B ENTERPRISES (hereinafter called the "Supplier") of the other part:
