



## CONTRACT AGREEMENT

Contract No. 2023-1189 SVP

THIS AGREEMENT made this **26th** day of **May**, **2023** between **Ma. Ester E. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted ( e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Performance Security;

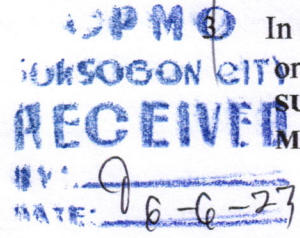
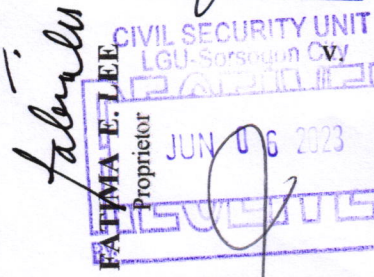
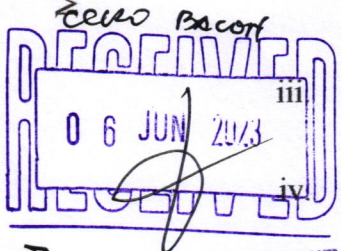
Notice of Award of Contract; and the Bidder's conforme thereto; and



4. The City Government of Sorsogon agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




