## CONSTRUCTION OF LOCAL ROAD - PHASE II @ RED PALM, ILAWOD, PANGPANG CW 2023-07-044

- 1. The City Government of Sorsogon, through the 20% CDF CDC EXECOM RES. NO.1 2/2/2023 intends to apply the sum of One Million Seven Hundred Eighty Six Thousand Four Hundred Seventy Seven & 18/100 Pesos (Php ₱ 1,786,477.18 ) Only being the Approved Budget for the Contract (ABC) to payments under the contract for CONSTRUCTION OF LOCAL ROAD PHASE II @ RED PALM, ILAWOD, PANGPANG under Project Reference No. CW 2023-07-044 . Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *City Government of Sorsogon* now invites bids for the above Procurement Project. Completion of the Works is required *with in* <u>72 calendar days</u>. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from *Bids and Awards Committee of the City Government of Sorsogon* and inspect the Bidding Documents at the address given below from *9:00A.M to 3:00 PM Only*.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on **July 10**, **2023** from given address and website/s <u>sorsogoncity.gov.ph</u> and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand** (**P 5,000.00**). The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
- 6. The City Government of Sorsogon will hold a Pre-Bid Conference<sup>1</sup> on **July 17**, **2023** @ **2:00pm** at BAC Office, City Hall, Cabid-an, East District, Sorsogon City which shall be open to prospective bidders however **SHALL** observed the minimum health protocol.
- 7. Bids must be duly received by the BAC Secretariat on August 1, 2023 at 9:00 A.M through the authorized representative of the bidder who is also responsible in the observance of the health protocol. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
- 9. Bid opening shall be on *August 1, 2023; 10:00 a.m.* at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The *City Government of Sorsogon* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in
