The City Government of Sorsogon, through the 2023 LGSF-SBDP intends to apply the sum of Six Million Six Hundred Six Thousand Eight Hundred Eighty Two & 17/100 Pesos (₱ 6,606,882.17) Only being the total Approved Budget for the Contract (ABC) to payments under the contract for REHAB/IMPROVEMENTOF LEVEL III POTABLE WATER SUPPLY SYSTEM @SAN JUAN BACON DIST. under Project Reference No. CW 2023-08-058 . Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *City Government of Sorsogon* now invites bids for the above Procurement Project. Completion of the Works is required with in *120 calendar days* _ . Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from *Bids and Awards Committee of the City Government of Sorsogon* and inspect the Bidding Documents at the address given below from 9:00A.M to 3:00 PM Only.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on **August 24**, **2023** from given address and website/s sorsogoncity.gov.ph and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand** (**P 10**,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
- 6. The *City Government of Sorsogon* will hold a Pre-Bid Conference¹ on *September 1*, 2023 @ 9:00am at *BAC Office*, *City Hall, Cabid-an, East District, Sorsogon City* which shall be open to prospective bidders however **SHALL** observed compliance with the requirements stipulated in the ITB.
- 7. Bids must be duly received by the BAC Secretariat on *September 14, 2023 at 9:00 A.M* through the authorized representative of the bidder . Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
- 9. Bid opening shall be on *September 14, 2023; 10:00 a.m.* at the given address below Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
