CONTRACT AGREEMENT

THIS AGREEMENT, made this <u>31st</u> day of <u>March</u>, <u>2023</u> between CITY GOVERNMENT OF SORSOGON, City Hall, Cabid-an East Dist. Sorsogon City (hereinafter called the "Entity") and JAYRO CONSTRUCTION & SUPPLY, V.L. Peralta St. Burabod, East District, Sorsogon City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **REHABILITATION OF LOCAL ROAD@ IRAYA, BATUHAN, SAN ROQUE and was corrected by virtue of SP Resolution No. 018** Series of 2023 to CONSTRUCTION OF LOCAL ROADS @ IRAYA, BATUHAN, SAN ROQUE, **BACON DIST SORSOGON CITY** under Contract Reference No. CW 2022-10-070 (hereinafter called "the Works") and the Entity has accepted the Bid for **One Million Six Hundred Ninety Seven Thousand Three Hundred One & 27/100 Pesos (Php 1,697,301.27) Only** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional</u> <u>contract documents or information prescribed by the GPPB that are</u> <u>subsequently required for submission after the contract execution, such as</u> <u>the Notice to Proceed, Variation Orders, and Warranty Security, shall</u> <u>likewise form part of the Contract.</u>

In consideration for the sum of **One Million Six Hundred Ninety Seven Thousand Three Hundred One & 27/100 Pesos (Php 1,697,301.27) Only** or such other sums as may be ascertained, **JAYRO CONSTRUCTION & SUPPLY** agrees to **REHABILITATION OF LOCAL ROAD@ IRAYA, BATUHAN, SAN ROQUE** and was corrected by virtue of SP Resolution No. 018 Series of 2023 to **CONSTRUCTION OF LOCAL ROADS @ IRAYA, BATUHAN, SAN ROQUE**, **BACON DIST** Sorsogon City in accordance with his/her/its Bid.
