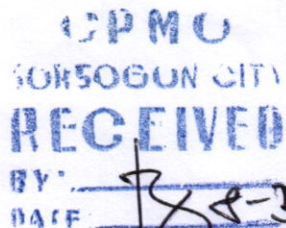

THIS AGREEMENT made this **28th** day of **July**, **2023** between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the " Entity") of the one part and **MS. JOANNA MABELLE M. BELTRAN** Proprietor of **JMBEL Enterprises** (hereinafter called the "Supplier") of the other part:

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

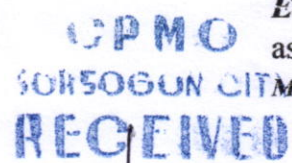
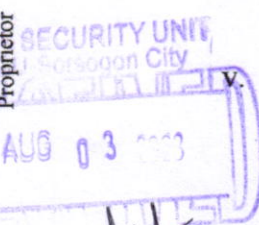
