CONTRACT AGREEMENT

THIS AGREEMENT made this 19th day of May, 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and PAUL DESCALLAR DINO Proprietor RMM CATERING SERVICES (hereinafter called the "Supplier") of the other part:


