CONTRACT AGREEMENT

THIS AGREEMENT made this **9th** day of **June**, **2023** between **Ma. Ester E. Hamor**, **City Mayor**, **City of Sorsogon** Philippines (hereinafter called the "Entity") of the one part and **JUDITH A. TUMALAD** proprietor of **JAD MARKETING** (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz SUPPLY AND DELIVERY OF MATERIAL AND SUPPLIES FOR THE PILI FESTIVAL FUN RUN and has accepted a Bid by the Supplier for the supply of those goods and services in the sum Four Hundred Thousand Pesos (₱ 400,000.00) Only (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Performance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> <u>additional contract documents or information prescribed by the GPPB</u> <u>that are subsequently required for submission after the contract execution,</u> <u>such as the Notice to Proceed, Variation Orders, and Warranty Security,</u> <u>shall likewise form part of the Contract.</u>

In consideration for the sum of *Four Hundred Thousand Pesos* (**P** 400,000.00) Only or such other sums as may be ascertained, *JAD MARKETING* agrees to the SUPPLY AND DELIVERY OF MATERIAL AND SUPPLIES FOR THE PILI FESTIVAL FUN RUN in accordance with his/her/its Bid.
