- 1. The City Government of Sorsogon, through the 20% CDF intends to apply the sum of Four Million Nine Hundred Ninety-Nine Thousand Seven Hundred Twenty-Eight & 80/100 Pesos (\$\mathbf{P}\$ 4,999,728.80) Only being the total Approved Budget for the Contract (ABC) to payments under the contract for ESTABLISHMENT OF RELOCATION SITE AND CONSTRUCTION OF HOUSING UNITS @ Barangay Bibincahan, East District under Project Reference No. CW 2023-09-069 . Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *City Government of Sorsogon* now invites bids for the above Procurement Project. Completion of the Works is required with in *365 calendar days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from *Bids and Awards Committee of the City Government of Sorsogon* and inspect the Bidding Documents at the address given below from 9:00A.M to 3:00 PM Only.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on **September 6, 2023** from given address and website/s <u>sorsogoncity.gov.ph</u> and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand (P 5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
- 6. The City Government of Sorsogon will hold a Pre-Bid Conference¹ on September 13, 2023 @ 10:00am at BAC Office, City Hall, Cabid-an, East District, Sorsogon City which shall be open to prospective bidders however SHALL observed compliance with the requirements stipulated in the ITB.
- 7. Bids must be duly received by the BAC Secretariat on *September 26, 2023 at 1:00 PM* through the authorized representative of the bidder. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
- 9. Bid opening shall be on *September 26, 2023; 2:00 PM*. at the given address below Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
