## **CONTRACT AGREEMENT**

THIS AGREEMENT made this 14th day of July , 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and IRISJ JAZMIN proprietor of IJ & J ENTERPRISES (hereinafter called the "Supplier") of the other part:




