



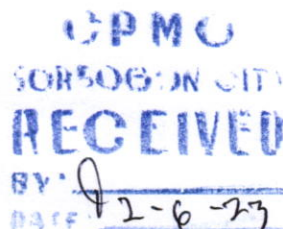

CONTRACT AGREEMENT

THIS AGREEMENT made this **27th** day of **January**, **2023** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines (hereinafter called the " Entity") of the one part and **FATIMA E. LEE** proprietor of **F.E. - iii. Performance Security;

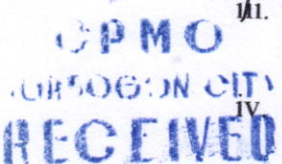
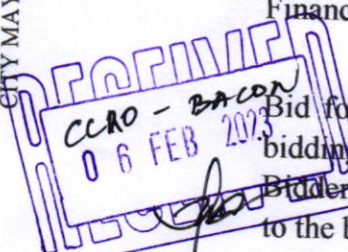
iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

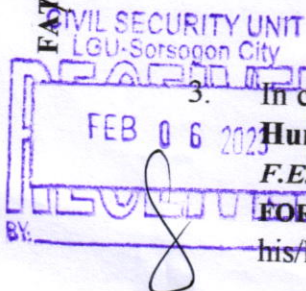

4. The City Government of Sorsogon agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


