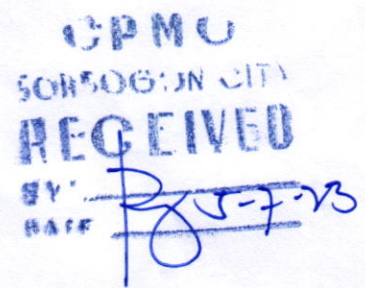
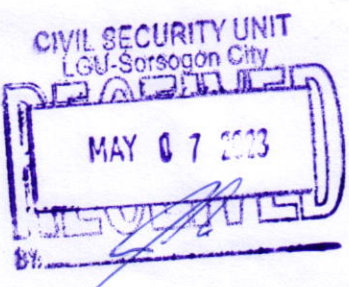

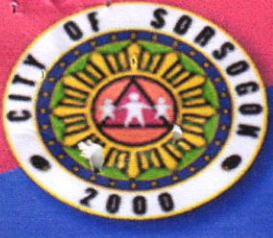

CONTRACT AGREEMENT

Contract No. 2023-1097 SVP

THIS AGREEMENT made this **11th** day of **May**, **2023** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines (hereinafter called the " Entity") of the one part and **ARIEL D. DESPUIG** proprietor of **ARSSI CONSTRUCTION AND SUPPLY** (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **SUPPLY AND DELIVERY OF MATERIALS FOR THE FABRICATION OF PROMOTIONAL SIGNAGES FOR THE GAYON BACON FESTIVAL** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Hundred Ten Thousand Four Hundred Pesos (P ₱110,400.00) Only** (hereinafter called "the Contract Price").

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Performance Security;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

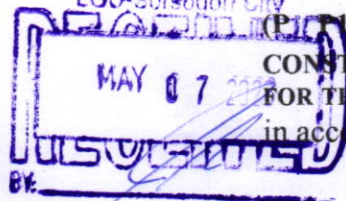
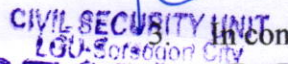
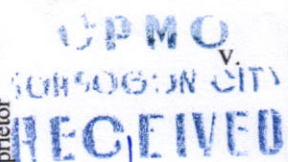

In consideration for the sum of **One Hundred Ten Thousand Four Hundred Pesos (P ₱110,400.00) Only** or such other sums as may be ascertained, **ARSSI CONSTRUCTION AND SUPPLY** agrees to **SUPPLY AND DELIVERY OF MATERIALS FOR THE FABRICATION OF PROMOTIONAL SIGNAGES FOR THE GAYON BACON FESTIVAL** in accordance with his/her/its Bid.




