CONTRACT AGREEMENT

Contract No. 2023- 1974 SVP

THIS AGREEMENT made this **1st** day of **September , 2023** between **Ma. Ester E. Hamor , City Mayor, City of Sorsogon** Philippines (hereinafter called the “ Entity”) of the one part and **DAISY T. SERILLA** proprietor of **GOSHEN CONSTRUCTION** (hereinafter called the “Supplier”) of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **REPAIR & MAINTENANCE OF DRAINAGE/ELECT/WATER SYSTEM @ SORSOGON CITY PUBLIC MKT** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Hundred Fifty Three Thousand Seven Hundred Fifty Eight & 50/100 Pesos (Php 153,758.50) Only** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

Performance Security;

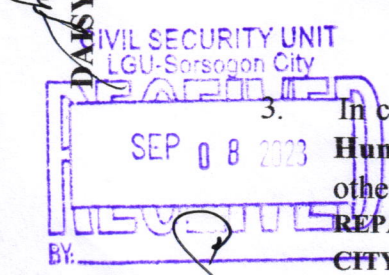
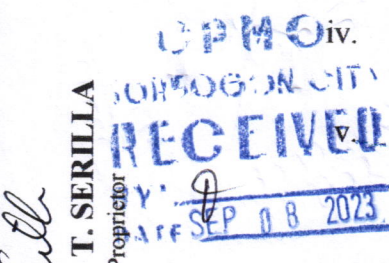
iv. Notice of Award of Contract; and the Bidder’s conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **One Hundred Fifty Three Thousand Seven Hundred Fifty Eight & 50/100 Pesos (Php 153,758.50) Only** or such other sums as may be ascertained, **GOSHEN CONSTRUCTION** agrees to **REPAIR & MAINTENANCE OF DRAINAGE/ELECT/WATER SYSTEM @ SORSOGON CITY PUBLIC MKT** in accordance with his/her/its Bid.

4. The City Government of Sorsogon agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






