

CONTRACT AGREEMENT

THIS AGREEMENT made this **31st** day of **August**, **2023** between **Ma. Ester E. Hamor**, **City Mayor**, **City of Sorsogon** Philippines (hereinafter called the "Entity") of the one part and **ARIEL D. DESPUIG** proprietor of **ARSSI CONSTRUCTION AND SUPPLY** (hereinafter called the "Supplier") of the other part:
