CONTRACT AGREEMENT

THIS AGREEMENT, made this <u>1st</u> day of <u>August</u>, <u>2023</u> between *CITY* GOVERNMENT OF SORSOGON, City Hall, Cabid-an East Dist. Sorsogon City (hereinafter called the "Entity") and **NJNY CONSTRUCTION & SUPPLY** with office address @ Employees Housing, Diversion Road, Cabid-an, Sorsogon, City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **REPAIR/IMPROVEMENT OF MULTI-PURPOSE HALL - (EVACUATION CENTER) RIZAL, WEST DIST., Sorsogon City** *under Contract Reference No.* <u>CW 2023-05-025</u> (hereinafter called "the Works") and the Entity has accepted the Bid for **Two Million Nine Hundred Ninety Nine Thousand Three Hundred Fifty Nine Pesos (P 2,999,359.00) Only** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional</u> <u>contract documents or information prescribed by the GPPB that are</u> <u>subsequently required for submission after the contract execution, such as</u> <u>the Notice to Proceed, Variation Orders, and Warranty Security, shall</u> <u>likewise form part of the Contract.</u>
