CONTRACT AGREEMENT

Contract No. 2023-300 SVP

THIS AGREEMENT made this **10th** day of **February**, **2023** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines (hereinafter called the “ Entity”) of the one part and **JOSEPHINE J. - iv. Notice of Award of Contract; and the Bidder’s conforme thereto; and

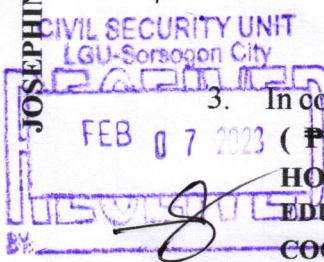
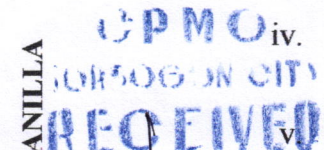
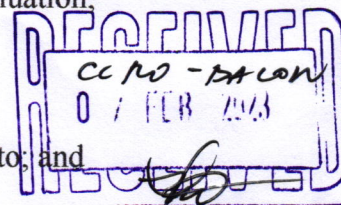
