Contract Agreement

THIS AGREEMENT made this **29th** day of **September**, **2023** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines (hereinafter called the " Entity") of the one part and **MS. JOANNA MABELLE M. BELTRAN** Proprietor of **JMBEL Enterprises** (hereinafter called the "Supplier") of the other part:

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of Two Million Nine Hundred Ninety Six Thousand Four Hundred Twenty One Pesos (P 2,996,421.00) Only or such other sums as may be ascertained, **JMBel Enterprises** agrees to **SUPPLY AND DELIVERY OF OFFICE SUPPLIES FOR THE 3RD QTR** in accordance with his/her/its Bid.


