### Contract Agreement

No. B- 2023-043-GS

THIS AGREEMENT made this **15th** day of **November ,2023** between **Ma. Ester E. Hamor , City Mayor, City of Sorsogon** Philippines ( hereinafter called the “ Entity”) of the one part and **MS. JOANNA MABELLE M. BELTRAN** Proprietor of **JMBEL Enterprises** ( hereinafter called the “Supplier”) of the other part:

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Thirteen Million Nine Hundred Sixty Thousand Six Hundred Pesos (₱ 13,960,600.00 ) Only** or such other sums as may be ascertained, **JMBel Enterprises** agrees to **SUPPLY AND DELIVERY OF CANNED FOOD STUFF AND PASTA** in accordance with his/her/its Bid.
