

CONTRACT AGREEMENT

THIS AGREEMENT made this 8th day of September , 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and ROBERTO D. DOLLISON JR. proprietor of BAGATAWO BUILDERS (hereinafter called the "Supplier") of the other part:
