





## CONTRACT AGREEMENT

THIS AGREEMENT made this 22<sup>nd</sup> day of September, 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines ( hereinafter called the " Entity" ) of the one part and MR. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

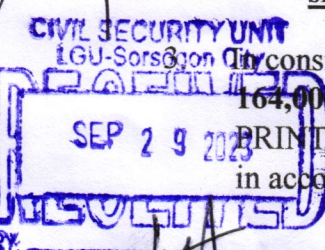
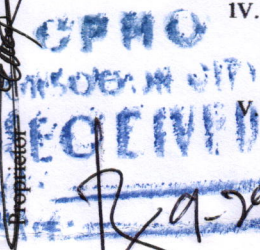
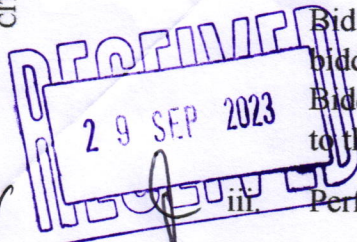
