CONTRACT AGREEMENT

THIS AGREEMENT, made this **5th** day of **October**, **2023** between **CITY GOVERNMENT OF SORSOGON, City Hall, Cabid-an East Dist. Sorsogon City** (hereinafter called the "Entity") and **YENZ CONSTRUCTION** with office address @ **Barangay Ilawod, Camalig Albay, Legazpi City** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **PROVISION OF RENEWABLE ENERGY BASED ELECT @ JAMISLAGAN, BACON DIST.,** under Contract Reference No. **CW 2023-08-051 L5** (hereinafter called "the Works") and the Entity has accepted the Bid for **Two Million Seven Hundred Eighty Two Thousand Six Hundred Fifteen & 36 /100 Pesos (P 2,782,615.36) Only** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **Two Million Seven Hundred Eighty Two Thousand Six Hundred Fifteen & 36 /100 Pesos (P 2,782,615.36) Only** or such other sums as may be ascertained, **YENZ CONSTRUCTION** agrees to **PROVISION OF RENEWABLE ENERGY BASED ELECT @ JAMISLAGAN, BACON DIST.,** in accordance with his/her/its Bid.
