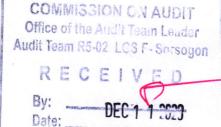

### **CONTRACT AGREEMENT**

THIS AGREEMENT made this 10th day of November , 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and JUDITH M. DOLLISON Authorized Partner of WRITESHOP ENTERPRISES ( hereinafter called the "Supplier") of the other part:
