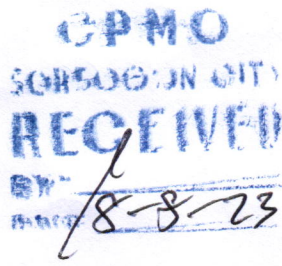
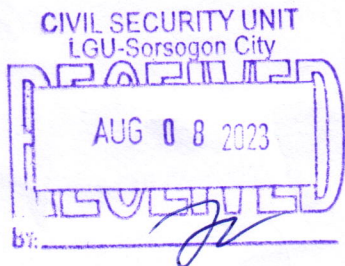

CONTRACT AGREEMENT

THIS AGREEMENT made this **3rd** day of **August**, **2023** between **Ma. Ester E. NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

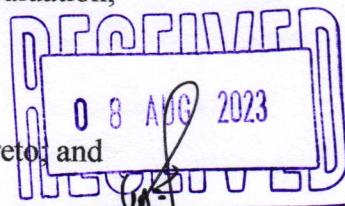
1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

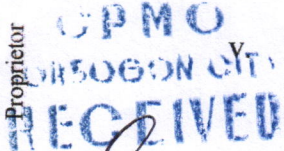
- iii. Performance Security;

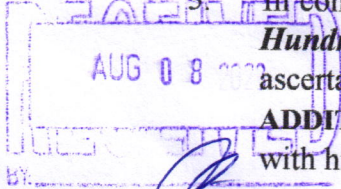

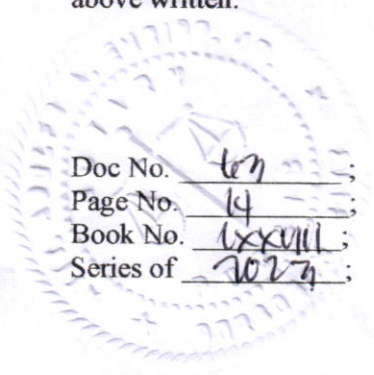


