

CONTRACT AGREEMENT

THIS AGREEMENT made this 1st day of September , 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and ARLENE ESMERIA SUNGA proprietor of MANG ALLAN STAINLESS STEEL FABRICATION AND SUPPLY (hereinafter called the "Supplier") of the other part:
