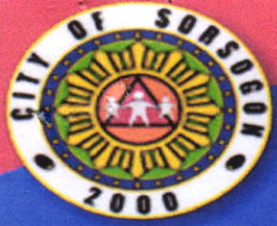

CONTRACT AGREEMENT

Contract No. 2023- 2133 SVP

THIS AGREEMENT made this 29th day of September, 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the " Entity") of the one part and ANTONIO J. RECIBIDO proprietor of A RECIBIDO ELECTRONICS REF. AND AIRCON REPAIR SHOP (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **REPLACEMENT OF 2-UNITS DEFFECTIVE AIRCON AT ENGG. OFFICE** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Hundred Eighty Three Thousand Eight Hundred Fifty Pesos (₱ 183,850.00) Only** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

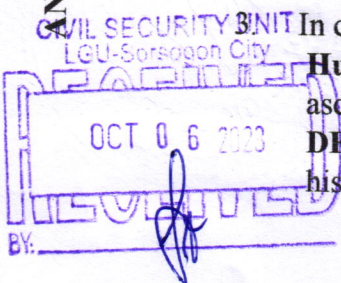
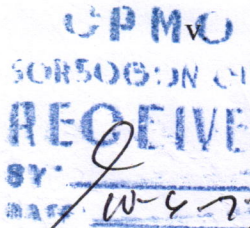
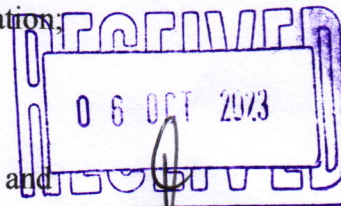
