

CONTRACT AGREEMENT

THIS AGREEMENT made this 18th day of October , 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and JOSE BONIFACIO L. LASALA proprietor of JL ENTERPRISES (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, SUPPLY AND DEL.  - Supplemental or Bid Bulletins, if any iv.
 - Winning bidder's bid, including the Eligibility requirements, Technical and ii. Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Performance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

Inconsideration for the sum of Seven Hundred Ninety Nine Thousand Nine Hundred Fifty Pesos (799,950.00) or such other sums as may be ascertained, JL ENTERPISES agrees to viz SUPPLY AND DELIVERY OF JANITORIAL SUPPLIES FOR USE AT CITY MAYOR'S OFFICE in accordance with his/her/its Bid.
