CONTRACT AGREEMENT

THIS AGREEMENT made this 27th day of October, 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and JUDITH M. DOLLISON Authorized Partner of WRITESHOP ENTERPRISES (hereinafter called the "Supplier") of the other part:
