## **CONTRACT AGREEMENT**

THIS AGREEMENT made this 1st day of December, 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and RHEA J. OLAYRES proprietor of BRYSAM ENTERPRISES (hereinafter called the "Supplier") of the other part:
