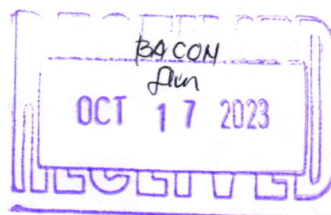
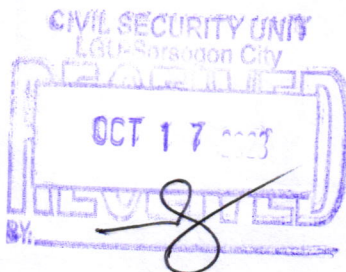

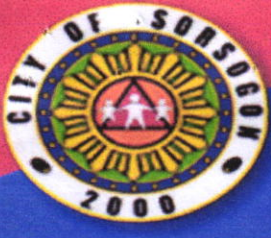

CONTRACT AGREEMENT

THIS AGREEMENT, made this 12th day of October, 2023 between CITY GOVERNMENT OF SORSOGON, City Hall, Cabid-an East Dist. Sorsogon City (hereinafter called the "Entity") and **KYLA CONSTRUCTION SUPPLY** with office address Caño Vicente Jr. Bldg W. Vinzon Street Baño, Legazpi City Albay (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **SUPPLY, FABRICATION AND INSTALLATION OF CHRISTMAS DECORATION @ Sorsogon City** under Contract Reference No. CW 2023-09-065 (hereinafter called "the Works") and the Entity has accepted the Bid for **Seven Million Four Hundred Twenty One Thousand One Hundred Sixteen & 50/100 Pesos (₱ 7,421,116.50) Only** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c. Performance Security;
 - d. Notice of Award of Contract and the Bidder's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **Seven Million Four Hundred Twenty One Thousand One Hundred Sixteen & 50/100 Pesos (₱ 7,421,116.50) Only** or such other sums as may be ascertained, **KYLA CONSTRUCTION SUPPLY** agrees to **SUPPLY, FABRICATION AND INSTALLATION OF CHRISTMAS DECORATION @ Sorsogon City** in accordance with his/her/its Bid.
