CONTRACT AGREEMENT

THIS AGREEMENT, made this **3rd** day of **November**, **2023** between CITY GOVERNMENT OF SORSOGON, City Hall, Cabid-an East Dist. Sorsogon City (hereinafter called the "Entity") and ALHADRAX CONTRUCTION & SUPPLY with office address Maningcay De Oro, Prieto Diaz, Sorsogon (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **CONSTRUCTION OF** HEALTH CENTER @ SAN JUAN (RORO) EAST DIST., SOR. - d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional</u> <u>contract documents or information prescribed by the GPPB that are</u> <u>subsequently required for submission after the contract execution, such as</u> <u>the Notice to Proceed, Variation Orders, and Warranty Security, shall</u> <u>likewise form part of the Contract.</u>

In consideration for the sum of **One Million Three Hundred Ninety Four Thousand Eight Hundred Eighty Eight & 92/100 Pesos (₱1,394,888.92)** or such other sums as may be ascertained, ALHADRAX CONTRUCTION & SUPPLY agrees to **CONSTRUCTION OF HEALTH CENTER** @ SAN JUAN (RORO) EAST **DIST.,SOR. CITY** in accordance with his/her/its Bid.
