

CONTRACT AGREEMENT

THIS AGREEMENT made this 1st day of September , 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and EUGENIO PERALTA MATEO III PROPRIETOR CASA DOMINGA RESTAURANT & VIDEOOKE BAR (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz CATERING SERVICES FOR THE LUNCH AND MEALS FOR THE MANDATORY TRICYCLE TRAINING WORKSHOP & ACCREDITATION and has accepted a Bid by the Supplier for the supply of those goods and services in the of Seventy Three Thousand One Hundred Twenty Five Pesos (P 73,125.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Performance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Phocuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.</u>
