





CONTRACT AGREEMENT

THIS AGREEMENT made this 29th day of September, 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and CHRISTOPHER C. VEGA proprietor of TROOPENG'S DINER (hereinafter called the "Supplier") of the other part:
