THIS AGREEMENT made this **20th** day of **October**, **2023** between **Ma. Ester E.  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

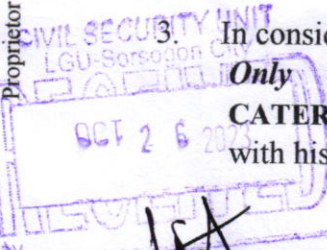
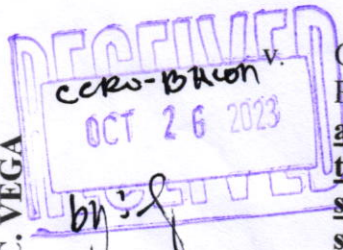

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **One Hundred Fifty Thousand Pesos (P 150,000.00) Only** or such other sums as may be ascertained, **TROOPENG'S DINER** agrees to **CATERING SERVICES DURING CONDUCT OF BSKE 10/29-30/2023** in accordance with his/her/its Bid.


