CONTRACT AGREEMENT

THIS AGREEMENT made this 13th day of December, 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and MA. CRISTINA E. DURAN proprietor of PAOPAO HOTEL RESIDENCES (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz CATERING SERVICES DURING THE YEAR END EVALUATION AND CITY EMPLOYEES FELLOWSHIP 2023 OF PERMANENT EMPLOYEES, ET.
