THIS AGREEMENT made this 13th day of December, 2023 between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the " Entity") of the one part and **MS. JUDITH M.  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;



Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **Four Hundred Ninety Seven Thousand Two Hundred Fifty Pesos (₱ 497,250.00) Only** or such other sums as may be ascertained, **YASHICA Enterprises** agrees to **RE-BID PROVISION OF MOTORIZED AND MOTORIZED FIBER GLASS BOAT WITH COMPLETE ACCESSORIES AND GEARS (L3)** in accordance with his/her/its Bid



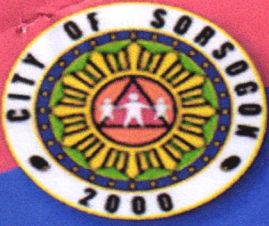
